I found the following facts:

04. That NIST (**National Institute Of Science & Technology**) is an Independent Organization, an autonomous body, registered under appropriate Government Act.

05. The term "Autonomous body" denotes a self-governing body, independent, or subject to its own laws. If autonomous body or institution is a company, it is regulated by the company law. If it is a society, it is governed by the law on registration of societies. But in both the cases, its own board of directors can specify the rules of business for the body / institution.
